TERMS AND CONDITIONS IN RESPECT OF Christmas Pass

1 Applicable Program

By participating in the program organized by K11 Loyalty Program Limited ("KLUB 11") as set out in clause 2 below (the "Program"), a participant is deemed to have read, understood and agreed to the terms and conditions applicable to the Program.

2 Details of the Program

2.1 KLUB 11 members ("Members") may redeem the following Bonus K Dollar Reward on the date of spending ("Reward") once per day upon reaching the below designated sameday spending threshold at K11 MUSEA and successfully registering the relevant Eligible Receipts and the corresponding Electronic Payment slips at KLUB 11 Koncierge on G/F or 4/F of K11 MUSEA (or via the on-site Sales Ambassadors or the Member's Elite Client Manager (if any)) on the date of the Eligible Transaction, subject to these Terms and Conditions.

^ Same-day spending is calculated based on a maximum of four (4) Eligible Receipts from a Participating Merchant (as defined in the KLUB 11 Program Terms and Conditions) at K11 MUSEA (but excluding any purchase of Apple iPhone products at MetroSix, Sunion, TechLife by fortress and 1010 & The Club and any purchase of pure gold pallets from Chow Tai Fook) excluding any spending by K Dollar(s) and/or K11 gift voucher(s), and if there are two (2) or more Eligible Receipts they shall be issued by at least 2 different Participating Merchants of K11 MUSEA. Each corresponding Eligible Receipt should contain a minimum spending of HK\$50 (excluding spending by K Dollar(s) and/or K11 gift voucher(s)).

*The KLUB Points distributed under the Reward will expire on 31 March 2021. Each Member is only entitled to redeem a maximum of 2,000 bonus K Dollars under the Program once per day during the Program Period.

3 Special Terms and Conditions applicable to the Program

3.1 Terms Used

- 3.1.1 "Eligible Receipt" means an original machine-printed receipt issued by a Participating Merchant at K11 MUSEA on the date of redemption for an Eligible Transaction.  - (c) any purchase of cash vouchers, gift cards or coupons, stored value cards or prepaid cards;
 - (d) any purchase of show/event/exhibition tickets;
 - (e) adding value to Octopus cards, stored value cards or pre-paid cards;
 - (f) installment, partial payment, deposit, or advance payments;
 - (g) any spending at K11 Art Mall, Hyatt Regency Hotel, K11 ARTUS, K11 Atelier (including Victoria Dockside & King's Road) and Rosewood Hong Kong;
 - (h) any spending at Victoria Playpark, D Mind & the Prince and Yan Toh Heen;
 - (i) charity donations;
 - (j) any purchase of membership;
 - (k) currency exchange;
 - (I) any bill payment (including but not limited to payment of telecommunication or utility bills)
 - (m) any bank transactions;
 - (n) EPS cash withdrawal, credit card withdrawal; and
 - (o) any other transaction as specified by KLUB 11 from time to time (with or without prior notice).
- 3.1.3 "Electronic Payment" means transaction by credit cards, debit cards, Android Pay, Apply Pay, Samsung Pay, WeChat Pay, Tap & Go, Alipay payment slip, Quick Pass and Octopus cards.
- 3.1.4 Other terms not defined in these Terms and Conditions shall have the same meanings as defined in the KLUB 11 Program Terms and Conditions.

3.2 Registration of Eligible Transactions

- 3.2.1 For the purpose of calculating the Eligible Transactions spending, all Eligible Transaction spending is required to be registered on the date of the Eligible Transaction at KLUB 11 Koncierge on G/F or 4/F of K11 MUSEA (or via the on-site K11 MUSEA Sales Ambassadors or the Member's Elite Client Manager (if any)) and in accordance with other requirements under the KLUB 11 Loyalty Program Terms and Conditions.
- 3.2.2 If any registered spending of Eligible Transactions is subsequently cancelled or reversed for whatever reasons, KLUB 11 reserves the right to request the relevant Member to refund to KLUB 11 the full or pro-rated amount of the received Reward.

3.3 Crediting and Use of the Reward

- 3.3.1 The Reward shall be credited to the relevant Members' account in the form of KLUB Points within 7 days from the date of successful registration of the relevant Eligible Transaction. KLUB 11 has the right to suspend, terminate or cancel the Program at any time without any prior notice.

4 General Terms and Conditions

4.1 Amendment

KLUB 11 has the right to amend these Terms and Conditions at any time without prior notice.

4.2 Interpretation

KLUB 11 has the right to interpret these Terms and Conditions. In case of disputes, the decision of KLUB 11 shall be final and binding on all parties concerned.

4.3 English Version Prevails

The Chinese version of these terms and conditions are for reference only. In case of discrepancies between the provisions of the English version and the Chinese version, the English version will prevail.

4.4 Governing Laws

These Terms and Conditions shall be governed by the laws of Hong Kong Special Administrative Region.

1 適用活動

2 活動詳情

 - (o) 由 KLUB 11 不時指定的任何其他交易 (不論事先通知與否)。
- 3.1.3「電子貨幣」指信用卡、借記卡、Android Pay、Apple Pay、Samsung Pay、WeChat Pay、拍住賞、支付寶、銀聯閃付的支付憑據及八達通卡簽賬。
- 3.1.4 其他沒有在本條款及細則中定義的條款與 KLUB 11 獎賞計劃條款及細則所作的 定義具有相同的涵義。

3.2 合資格登記
