TERMS AND CONDITIONS IN RESPECT OF

Hang Seng Credit Card Promotion 2023

(From 1 January to 31 March 2023)

1 Applicable Activity

By participation in the activity organized by K11 Loyalty Program Limited ("KLUB 11") as set out in clause 2 below (the "Activity"), a participant is deemed to have read, understood and agreed to the terms and conditions applicable to the Activity ("Terms and Conditions").

2 The details of the Activity

2.1 Promotional Offer 1:

During the Activity Period, participants who are both KLUB 11 Members and K Dollar Program Members and have bound their KLUB 11 Membership with their corresponding K Dollar Program account ("Members"), subject to these Terms and Conditions, may redeem the Rewards below ("Rewards") on the date of transaction upon reaching the designated same-day spending at merchants of K11 MUSEA with the same Eligible Credit Card:

Cumulative Same-day Spending Amount of Promotional Offer 1 is calculated based on a minimum of 2 and a maximum of 4 Eligible Receipts issued by merchants of K11 MUSEA using the same Eligible Credit Card or the electronic Eligible Credit Card bounded with the Eligible Mobile Payment, and each Eligible Receipt must contain a minimum spending of HK\$50, excluding spending by K Dollar(s), K11 physical / electronic gift voucher(s) and/ or e-voucher(s) issued by K11 MUSEA merchants. If 2 or more Eligible Receipts are used, they must be issued by at least 2 different merchants of K11 MUSEA.

3 Redemption Restrictions

3.1 Promotional Offer 1:

- 3.1.1 Each participant shall first become a KLUB 11 Member and a K Dollar Program Member, and bind their KLUB 11 Membership with their corresponding K Dollar Program account to redeem the Rewards, provided that he or she is not a current KLUB 11 Member and a K Dollar Program Member.
- 3.1.2 Promotional Offer 1 can only be redeemed on the day of Eligible Transaction and the Rewards from each tier of Cumulative Same-Day Spending Amount can only be redeemed once on the same day by each member.
- 3.1.3 Members are required to use the same Eligible Credit Card or payment account of Eligible

5 Special Terms and Conditions applicable to the Activity

5.1 Terms Used

5.1.1 "Eligible Credit Card" refers to any Hong Kong Dollar primary, combined additional, separate

- additional credit cards or UnionPay Dual Currency credit cards (applicable to Hong Kong Dollar sub-account only) issued by Hang Seng Bank Limited in Hong Kong (and its successors and assigns).
- 5.1.2 "Eligible Receipt" means an original machine-printed receipt issued by a merchant at K11 MUSEA on the date of redemption for an Eligible Transaction. KLUB 11 does not accept any photocopies or hand-written receipts and reserves the right not to accept any receipts that KLUB 11 suspects to be invalid, forged or issued not for genuine transactions or on other grounds without any need for explanation.
- 5.1.3 "Eligible Transaction" means a consumer transaction paid by an Eligible Credit Card and/or or the electronic Eligible Credit Card bounded with the Eligible Mobile Payment between a Member and a merchant at K11 MUSEA but excludes:
 - (a) any spending by cash;
 - (b) any spending by cash dollars;
 - (c) any single spending below HK\$50;
 - (d) any purchase of any kinds of membership(s);
 - (e) any purchase of pre-paid items, cash vouchers, gift cards or coupons, stored value cards or prepaid cards;
 - (f) any purchase of show/event/exhibition tickets;
 - (g) any payments using K11 gift vouchers;
 - (h) reload of Octopus cards, stored value cards or pre-paid cards;
 - (i) currency exchange;
 - (j) any spending at Hyatt Regency Hotel, K11 ARTUS, K11 ATELIER (including Victoria Dockside & King's Road) and Rosewood Hong Kong;
 - (k) any spending at Victoria Playpark, D Mind & the Prince and Lai Ching Heen;
 - (I) any transactions on K11 ESHOP, Food Ordering via 'K11 HK' Mobile App or any online platform of any merchants of K11 MUSEA;
 - (m) any bank transactions, spending at travel agent, insurance transactions and transactions at shortterm promotion booth;
 - (n) charity donations;
 - (o) any bill payment (including but not limited to payment of telecommunication or utility bills); and
 - (p) any activity or course provided or hosted by K11 Kulture Academy.
- 5.1.4 "Eligible Mobile Payment" means any mobile payment tools, including Apple Pay, Google Pay

 ™, Samsung Pay and UnionPay App which have bound with Eligible Credit Card.
- 5.1.5 "Participating Merchants" shall mean the merchants at K11 MUSEA which accept the use of K Dollars as payment or part payment for their transactions. The full list of Participating Merchants can be found at https://klub-11.com/k-dollar/.
- 5.1.6 Other terms not defined in these Terms and Conditions shall have the same meanings as defined in the KLUB 11 Programme Terms and Conditions.

5.2 Registration of Eligible Transactions

- 5.2.1 For the purpose of calculating the Eligible Transactions spending, all Eligible Transactions spending is required to be registered in accordance with the KLUB 11 Loyalty Programme Terms and Conditions.
- 5.2.2 A Member shall forthwith inform KLUB 11 of any transaction where Benefits (as defined in the KLUB 11 Loyalty Programme Terms and Conditions) / K Dollars have been earned/obtained/redeemed but such transaction is subsequently cancelled, refunded or reversed for whatever reasons. By redeeming this Rewards, Member agrees that K11 may collect, hold, process and use their personal data in accordance with the Privacy Policy Statement of KLUB 11. 5.4 Copying Eligible Receipts

KLUB 11 has the right to make an electronic copy of each Eligible Receipt or screenshot of the transaction record of Eligible Mobile Payment presented to KLUB 11 in the course of redemption and keep the electronic copies for audit purpose.

5.5 Marking on Eligible Receipts

KLUB 11 has the right to make any marks on each Eligible Receipt presented to KLUB 11 in the course of redemption. Except for Promotional Offer 1 and Promotional Offer 2, Eligible Receipts marked by KLUB 11 cannot be used again for participating in the Activity or for redeeming any other gifts or privileges in other promotional activities being held in K11 MUSEA, unless specified.
