

**TERMS AND CONDITIONS IN RESPECT OF
K11 Art Mall Golden Joy Spending Rewards
(From 24 September 2026 to 11 October 2026)**

1 Applicable Activity

By participating in the activity organized by KLUB 11 Loyalty Program Limited ("**KLUB 11**") as set out in Clause 2 below (the "**Activity**"), a participant is deemed to have read, understood and agreed to the terms and conditions applicable to the Activity ("**Terms and Conditions**").

2 Details of the Activity

Activity: K11 Art Mall Golden Joy Spending Rewards
Promotion Period: 24 September 2026 to 11 October 2026 (both days inclusive)
Redemption Hours: 10AM – 10PM
Place of Redemption: G/F, Concierge, K11 Art Mall

2.1 Rewards: e-Voucher Rewards

During the Promotion Period, participants who are both KLUB 11 Members and K Dollar Program Members and have bound their respective KLUB 11 Membership with their corresponding K Dollar Program account ("**Members**"), subject to these Terms and Conditions, may redeem the following rewards ("**Rewards**") on the date of Eligible Transaction upon reaching the designated cumulative same-day spending at the merchants of K11 Art Mall:

*Cumulative Same-Day Spending is calculated based on a maximum of 4 Eligible Receipts issued by the merchants at K11 Art Mall, and each Eligible Receipt must contain a minimum spending of HK\$50, excluding spending by K Dollar(s) and/or K11 physical / electronic gift voucher(s) and/or any physical/electronic gift voucher(s) issued by merchants. Cumulative Same-Day Spending Amount applies to the net amount after deduction of all applicable discounts, cash vouchers, and/or gift cards etc.

In case of more than four (4) Eligible Receipts are registered by a Member on the same day during the Promotion Period, the four (4) Eligible Receipts with the highest spending amount will be taken into account for the purpose of redeeming Offer.

Members must register their Eligible Transaction(s) with the relevant Eligible Receipt(s) and the corresponding Electronic Payment slip(s) in person at the Place of Redemption to redeem Reward during the Redemption Hours on the date of Eligible Transaction. Eligible receipts marked by KLUB 11 for the redemption of one Reward for this Activity cannot be reused to redeem gifts or rewards from other promotions, except for the "Visa Card Promotion 2026".

% The Rewards can only be redeemed on the day of Eligible Transaction and the rewards from each tier of the Cumulative Same-Day Spending can only be redeemed once on the same day. Eligible Receipts marked by KLUB 11 to redeem a spending tier of Reward cannot be used again for redeeming rewards under another spending tier of Reward. The Rewards are offered on a first come first served basis and are subject to the quota as stipulated.

The use of the e-Voucher(s) are subject to the terms and conditions as stated on the e-Voucher(s) and the relevant terms and conditions of the Designated Merchants for HK\$50 Golden Joy Retail and F&B Pass e-Voucher(s).

Redemption Restrictions to the Rewards:

- (a) The Rewards are only applicable to the Members who become a KLUB 11 Member and a K Dollar Program Member, and have bound their KLUB 11 Membership with their corresponding K Dollar Program account.
- (b) Members need to successfully register any Eligible Receipt(s) and the corresponding Electronic Payment slip(s) in accordance with the KLUB 11 Loyalty Programme Terms and Conditions.
- (c) Each Member is entitled to redeem the Rewards once per day during the Promotion Period. Each Eligible Receipt marked by KLUB 11 to redeem a spending tier of Rewards cannot be used again.
- (d) All Eligible Receipts must be issued from merchants of K11 Art Mall. Each Eligible Receipt can only be used once to redeem the Rewards.
- (e) The Rewards will be credited to the member's KLUB 11 account in the form of e-Voucher(s). The usage of the e-Voucher(s) are subject to the terms and conditions as stated on the e-Voucher(s) and the relevant terms and conditions of the merchants who accept such e-Voucher(s). Each of the e-Voucher(s) can only be used on or before the expiry date as stated on the respective e-Voucher(s).
- (f) HK\$50 Golden Joy Retail and F&B Pass e-Voucher can only be used as HK\$50 upon spending of HK\$300 or above (net amount) at any of the Designated Merchants at K11 Art Mall as listed in Appendix 1. Only one HK\$50 Golden Joy Retail and F&B Pass e-Voucher can be used in one Eligible Transaction. HK\$50 Golden Joy Retail and F&B Pass e-Voucher cannot be used in conjunction with other shopping vouchers / cash coupons.

3 Special Terms and Conditions applicable to the Activity

3.1 Terms Used

3.1.1 **"Eligible Receipt"** means an original machine-printed receipt issued by any of the merchant at K11 Art Mall on the date of redemption for an Eligible Transaction. KLUB 11 does not accept any photocopied or handwritten receipts and reserves the right not to accept any receipts that KLUB 11 suspects to be invalid, forged or issued not for genuine transactions or on other grounds without any need for explanation.

3.1.2 **"Eligible Transaction"** shall mean a consumer transaction paid by Electronic Payment methods between the Member and a merchant at K11 Art Mall, excluding the below transactions:

- (a) any single spending below HK\$50;
- (b) any spending by cash;

- (c) any transactions where the invoice and payment slip are not issued from the same branch of K11 Merchants as defined under KLUB 11 Loyalty Programme Terms and Conditions;
- (d) any purchase of any kinds of membership(s);
- (e) any purchase of pre-paid items, cash vouchers, gift cards or coupons, stored value cards or prepaid cards;
- (f) any purchase of show/event/exhibition tickets and other ticketing services;
- (g) any payments using K Dollars and/or K11 physical or electronic gift vouchers;
- (h) adding value to Octopus cards, stored value cards or pre-paid cards;
- (i) currency exchange;
- (j) any spending at Hyatt Regency Hotel, K11 ARTUS, K11 ATELIER (including Victoria Dockside & King's Road) and Rosewood Hong Kong;
- (k) any spending at Victoria Playpark, D Mind & the Prince, Gentry Club and Tesla Experience Center;
- (l) any transactions on the online platform of any merchants of K11 MUSEA;
- (m) charity donations;
- (n) any bill payment (including but not limited to payment of telecommunication or utility bills)
- (o) any bank transactions; spending at travel agent; insurance transactions and transactions at short-term promotion booth;
- (p) any online shopping or payment;
- (q) EPS cash withdrawal or credit card cash withdrawal;
- (r) any other transactions as specified by KLUB 11 Loyalty Program Limited ("KLUB 11") as ineligible transactions; and
- (s) any spending at particular merchants as stated in KLUB 11 Loyalty Programme Terms and Conditions (which may be updated from time to time without prior notice).

3.1.3 **"Electronic Payment"** means transaction by credit cards, debit cards, EPS, Android Pay, Apple Pay, PayMe, Samsung Pay, WeChat Pay, Tap & Go, Alipay, UnionPay Mobile QuickPass and Octopus cards.

3.1.4 **"Designated Merchants for HK\$50 Golden Joy Retail and F&B Pass e-Voucher(s)"** shall mean the list of designated merchants who accept the HK\$50 Golden Joy Retail and F&B Pass e-Voucher(s) at K11 Art Mall as set out in Appendix 1.

3.1.5 **"KLUB 11 Loyalty Programme Terms and Conditions"** means the terms and conditions listed at <https://klub-11.com/program-terms-and-conditions/> (which may be updated by KLUB 11 from time to time).

3.1.6 Other terms not defined in these Terms and Conditions shall have the same meanings as defined in the KLUB 11 Loyalty Programme Terms and Conditions.

3.2 Registration of Eligible Transactions

3.2.1 For the purpose of calculating the Eligible Transactions spending, all Eligible Transactions spending is required to be registered in accordance with the KLUB 11 Loyalty Programme Terms and Conditions.

3.2.2 A Member shall forthwith inform KLUB 11 of any transaction where Benefits (as defined in the KLUB 11 Loyalty Programme Terms and Conditions) / K Dollars have been earned/obtained/redeemed but such transaction is subsequently cancelled, refunded or reversed for whatever reasons. In such circumstances, if the Member fails to inform KLUB 11 but it has come to the knowledge of KLUB 11 of those cancelled, refunded or reversed transaction(s), then either: (a) the Member shall pay to KLUB 11 forthwith upon notice from KLUB 11 for the value of the Benefits, which value shall be determined by KLUB 11 in its sole and absolute discretion; or (b) KLUB 11 shall be entitled to deduct the Benefits/K Dollars earned from the said transaction(s) from his/her account. The Member agrees that the aforesaid payment by the Member to KLUB 11 is an agreed liquidated damages but not a penalty.

3.3 Copying Eligible Receipts

KLUB 11 has the right to make an electronic copy of each Eligible Receipt presented to KLUB 11 in the course of redemption and keep the electronic copies for audit purpose.

3.4 Marking on Eligible Receipts

KLUB 11 has the right to make any marks on each Eligible Receipt presented to KLUB 11 in the course of redemption. The Eligible Receipt marked by KLUB 11 cannot be used again for participating in the Activity or for redeeming gifts or privileges from other promotions, except for the 'Visa Card Promotion 2026'.

3.5 Verification of Identify

Members are required to present his or her KLUB 11 and K Dollar Program e-membership card and show the linkage of the two memberships for verification at the time of redemption.

3.6 Cancelled Transactions

If the transaction for participating in the Activity is subsequently cancelled or reversed for whatever reasons, KLUB 11 has the right to deduct from the Member's account the relevant K Points redeemed from the said transaction.

3.7 No Exchange

The Rewards cannot be exchanged for cash or other gifts.

3.8 Limited Stock

The Rewards are offered on a first-come-first-served basis while stocks last.

3.9 Quality of Goods and Services

Goods and services to be redeemed under the Rewards are not provided by KLUB 11. KLUB 11 shall not be liable for the quality of such goods and services and any replacement or refund thereof.

3.10 No Liability

KLUB 11 does not warrant that the products and services offered by individual merchants or redeemed by the participants in the Activity are of any merchantable quality or fit for any purpose, and disclaims all liability in relation to such products and services. Any participant in the Activity shall waive all his/her rights and interests, if any, of any natures to pursue against KLUB 11.

3.11 No Warranty

KLUB 11 is not the provider of the services and/or goods to be redeemed e-Voucher(s) and makes no representation or warranty in relation to the same. KLUB 11 shall not be liable for any loss or damage whatsoever or for personal injury which is suffered or sustained, as a result of taking or using any such services or products, except for any liability which cannot be excluded by law.

3.12 Termination of the Activity

KLUB 11 has the right to suspend, terminate or cancel the Activity at any time without any prior notice.

4 General Terms and Conditions applicable to the Activity

4.1 Amendment

KLUB 11 has the right to amend any of these Terms and Conditions at any time without any prior notice.

4.2 Interpretation

KLUB 11 has the right to interpret these Terms and Conditions. In case of disputes, the decision of KLUB 11 will be final and binding on all parties concerned.

4.3 English Version Prevails

The Chinese version of these Terms and Conditions are for reference only. In case of discrepancies between the provisions of the English version and the Chinese version, the English version shall prevail.

4.4 Governing Laws

These Terms and Conditions shall be governed by the laws of Hong Kong Special Administrative Region.

1 適用活動

透過參與下文第 2 條中所載由 KLUB 11 會員獎賞計劃（「**KLUB 11**」）組織的活動（「**活動**」），參與者即被視為已閱讀、理解並同意適用於活動的條款及細則（「**條款及細則**」）。

2 活動詳情

換領時間： 上午 10 點至晚上 10 點
換領地點： K11 Art Mall 地下服務台

2.1 獎賞：電子禮券獎賞

於推廣期內，同時登記為 KLUB 11 會員及 K Dollar 獎賞計劃會員，並將其 KLUB 11 會籍綁定其相應的 K Dollar 獎賞計劃會籍的參與者（「會員」），於 K11 MUSEA 內之商戶同日累積消費滿指定金額，即可在合資格交易當日換領以下獎賞（「獎賞」），活動受以下條款及細則約束：

- l) 在 K11 MUSEA 商戶的網上購物平台進行的任何交易；
- m) 慈善捐款；
- n) 任何帳單支付（包括但不限於電訊或公用事業帳單支付）；
- o) 任何銀行交易；旅行社消費；保險交易；短期促銷攤位交易；
- p) 任何網上購物或線上支付；
- q) EPS 現金提款或信用卡提款；
- r) 任何被 K11 Loyalty Program Limited ("KLUB 11") 歸類為不合格

- 交易的任何交易；及
- s) 任何於 KLUB 11 會員獎賞計劃條款及細則(可能會不時更新恕不事先通知)內參與的商戶的交易。

3.1.3 「電子貨幣」指信用卡、借記卡、易辦事、Android Pay、Apple Pay、PayMe、Samsung Pay、WeChat Pay、拍住賞、支付寶、銀聯閃付及八達通卡簽賬。

3.1.4 「HK\$50 黃金週購物及美食電子禮券指定商戶」是指附表 1 列明於 K11 Art Mall 內接受 HK\$50 黃金週購物及美食電子禮券的指定商戶名單。

3.1.5 「KLUB 11 會員獎賞計劃條款和條件」指的是列在 <https://klub11.com/zh-hk/programterms-and-conditions/> 上的條款和條件 (KLUB 11 可能會不時更新)。

3.1.6 此等條款及細則中未定義的其他術語應具有與 KLUB 11 會員獎賞計劃條款及細則中定義的相同含義。

3.2 合資格交易登記

3.2.1 所有合資格交易須根據 KLUB 11 會員獎賞計劃條款及細則作登記，以計算在合資格交易的消費金額。
