

**TERMS AND CONDITIONS IN RESPECT OF
K11 MUSEA Bloom In Style Spending Rewards
(28 January 2026 – 24 February 2026)**

1 Applicable Activity

By participating in the activity organized by K11 Loyalty Program Limited (“**KLUB 11**”) as set out in clause 2 below (the “**Activity**”), a participant is deemed to have read, understood and agreed to the terms and conditions applicable to the Activity (“**Terms and Conditions**”).

2 The details of Activity

During the Promotion Period, participants who are both KLUB 11 Members and K Dollar Program Members and have bound their KLUB 11 Membership with their corresponding K Dollar Program account (“**Members**”), subject to these Terms and Conditions, may redeem the following reward (“**Reward**”) on the date of Eligible Transaction upon reaching the designated cumulative same-day spending (excluding spending by K Dollar(s) and K11 physical / electronic gift voucher(s), and/or any physical/electronic gift voucher(s) issued by merchants) at any merchants of K11 MUSEA:

3. Special Terms and Conditions applicable to the Activity

3.1. Terms Used

- 3.1.1. “**Eligible Receipt**” means an original machine-printed receipt issued by any of the merchants of K11 MUSEA for an Eligible Transaction. KLUB 11 does not accept any photocopies or handwritten receipts and reserves the right not to accept any receipts that KLUB 11 suspects to be invalid, forged or issued not for genuine transactions or on other grounds without any need for explanation.
- 3.1.2. “**Eligible Transaction**” shall mean a consumer transaction paid by Electronic Payment methods between the Member and a merchant at K11 MUSEA, excluding the below transactions:
 - a) any single spending below HKD50;
 - b) any spending by cash;
 - c) any transactions where the invoice and payment slip are not issued from the same branch of K11 Merchants as defined under KLUB 11 Loyalty Programme Terms and Conditions;

- d) any purchase of any kinds of membership(s) (except purchase of membership of PURE Fitness at K11 MUSEA);
 - e) any purchase of pre-paid items, cash vouchers, gift cards (including K11 MUSEA Gift Card) or coupons, stored value cards or pre-paid cards;
 - f) any purchase of show/event/exhibition tickets and other ticketing services;
 - g) any payments using K Dollars and/or K11 physical or electronic gift vouchers;

 - p) any bank transactions; spending at travel agent; insurance transactions and transactions at short-term promotion booth;

 - r) EPS cash withdrawal or credit card cash withdrawal;
 - s) any other transactions as specified by K11 Loyalty Program Limited ("KLUB 11") as ineligible transactions; and
 - t) any spending at particular merchants as stated in KLUB 11 Loyalty Programme Terms and Conditions (which may be updated from time to time without prior notice).
- 3.1.3. **"Electronic Payment"** means transaction by credit cards, debit cards, EPS, Android Pay, Apple Pay, BoC Pay, PayMe, Samsung Pay, WeChat Pay, Tap & Go, Alipay, Quick Pass and Octopus cards.
- 3.1.4. **"Designated Merchants for HK\$100 New Year Retail Pass e-Voucher(s)"** shall mean the list of designated merchants who accept the HK\$100 New Year Retail Pass e-Voucher(s) at K11 MUSEA as set out in Appendix 1.
- 3.1.5. **"Designated Merchants for HK\$200 New Year Retail Pass e-Voucher(s)"** shall mean the list of designated merchants who accept the HK\$200 New Year Retail Pass e-Voucher(s) at K11 MUSEA as set out in Appendix 1.
- 3.1.6. **"Designated Merchants for HK\$200 New Year Beauty Pass e-Voucher(s)"** shall mean the list of designated merchants who accept the HK\$200 New Year Beauty Pass e-Voucher(s) at K11 MUSEA as set out in Appendix 2.
- 3.1.7. **"Designated Merchants for HK\$500 New Year Luxury Pass e-Voucher(s)"** shall mean the list of designated merchants who accept the HK\$500 New Year Luxury Pass e-Voucher(s) at K11 MUSEA as set out in Appendix 3.
- 3.1.8. **"KLUB 11 Loyalty Programme Terms and Conditions"** means the terms and conditions listed at <https://klub-11.com/program-terms-and-conditions/> (which may be updated by KLUB 11 from time to time).
- 3.1.9. Other terms not defined in these Terms and Conditions shall have the same meanings as defined in the KLUB 11 Loyalty Programme Terms and Conditions.

3.2. Registration of Eligible Transactions

- 3.2.1. For the purpose of calculating the Eligible Transactions spending, all Eligible Transactions spending is required to be registered in accordance with the KLUB 11 Loyalty Programme Terms and Conditions.
- 3.2.2. A Member shall forthwith inform KLUB 11 of any transaction where Benefits (as defined in the KLUB 11 Loyalty Programme Terms and Conditions) / K Dollars have been earned/obtained/redeemed but such transaction is subsequently cancelled, refunded or reversed for whatever reasons. 3.4. Marking on Eligible Receipts

KLUB 11 has the right to make any marks on each Eligible Receipt presented to KLUB 11 in the course of redemption. The Eligible Receipt marked by KLUB 11 cannot be used again for participating in the Activity or for redeeming gifts or privileges from other promotions.

3.5. Verification of Identity

KLUB 11 Member shall present his or her original valid e-membership card for inspection at the time of redemption.

3.6. Cancelled Transactions

3.10. No Warranty

KLUB 11 is not the provider of the services and/or goods to be redeemed by e-Vouchers and makes no representation or warranty in relation to the same. KLUB 11 shall not be liable for any loss or damage whatsoever or for personal injury which is suffered or sustained, as a result of taking or using any such services or products, except for any liability which cannot be excluded by law.

3.11. Termination of the Activity

KLUB 11 has the right to suspend, terminate, or cancel the Activity at any time without any prior notice.

4. General Terms and Conditions applicable to the Activity

4.1. Amendment

KLUB 11 has the right to amend any these Terms and Conditions at any time without any prior notice.

4.2. Interpretation

KLUB 11 has the right to interpret these Terms and Conditions. In case of disputes, the decision of KLUB 11 will be final and binding on all parties concerned.

4.3. English Version Prevails

The Chinese version of these Terms and Conditions are for reference only. In case of discrepancies between the provisions of the English version and the Chinese version, the English version shall prevail.

4.4. Governing Laws

These Terms and Conditions shall be governed by the laws of Hong Kong Special Administrative Region.

3.1.3 「電子貨幣」指信用卡、借記卡、易辦事、Android Pay、Apple Pay、BoC Pay、PayMe、Samsung Pay、WeChat Pay、拍住賞、支付寶、銀聯閃付及八達通卡簽賬。

3.1.7 「港幣 500 元新春精品電子禮券指定商戶」是指於附表 3 列明 K11 MUSEA

內接受港幣 500 元新春精品電子禮券的指定商戶名單。

3.1.8 「KLUB 11 會員獎賞計劃條款和條件」指的是列在 <https://klub-11.com/zh-hk/program-terms-and-conditions/> 上的條款和條件（KLUB 11 可能會不時更新）。

3.1.9 其他沒有在本條款和條件中定義的條款與 KLUB 11 會員獎賞計劃條款及條件所作的定義具有相同的涵義。

3.2 合資格交易登記
